January 29, 2019
(All Mail Ballot Election)

All section references are to the Elections Code unless stated otherwise.

December 11, 2018 (E-49)	<u>RESOLUTION CALLING THE ELECTION:</u> Seal Beach City Council passed a resolution calling for a Municipal Run-Off Election to be held on January 29, 2019.
December 11, 2018 (E-49)	<u>REQUEST FOR RANDOMIZED ALPHABET DRAWING:</u> The Registrar of Voters notifies the Secretary of State by registered mail of the date of the election and requests a random draw. The Secretary of State's office will conduct the Random Draw. § 13113
December 12, 2018 (E-48)	<u>RANDOMIZED ALPHABET DRAW RECEIVED:</u> The Secretary of State's office provides the Registrar of Voters' office with the randomized Alphabet Drawing. This determines the order in which candidates appear on the ballot for this election.
December 18, 2018 (E-42)	<u>CANDIDATES' STATEMENTS:</u> Date that Candidates' Statements are due to the City Clerk's office.
December 31, 2018 (E-29)	<u>COMBINED VOTER INFORMATION GUIDE AND MAIL BALLOT:</u> First day to mail combined Voter Information Guides and mail ballots to voters. § 4101
January 14, 2019 (E-15)	<u>LAST DAY TO REGISTER TO VOTE IN THE CITY OF SEAL BEACH MUNICIPAL RUN-OFF ELECTION:</u> Last day to register to vote in the City of Seal Beach Municipal Run-Off Election. The Voter Registration Form shall be mailed (postmarked by this date) or delivered to the county elections official by this date and is effective upon receipt. Last day for military or overseas voters to register to vote, to request a vote-by-mail ballot, and to send it to the county elections official. § 2102
January 15, 2019 through January 29, 2019 (E-14 – 0)	<u>CONDITIONAL VOTER REGISTRATION PERIOD:</u> During the period 14 days prior to Election Day and including Election Day, an individual can go to the office of his/her county elections official to conditionally register to vote and vote a provisional ballot. § 2170

NEW CITIZEN REGISTRATION PERIOD: A new citizen is eligible to register and vote at the office of the county elections official at any time beginning on **January 15, 2019** and ending at the close of polls on **January 29, 2019**.

A new citizen registering to vote after the close of registration shall provide the county elections official with proof of citizenship prior to voting and shall declare that he or she has established residency in California.

The ballots of new citizens shall be received and canvassed at the same time and under the same procedure as vote-by-mail voter ballots.

VOTE-BY-MAIL BOARDS COMMENCE TO PROCESS VOTE-BY-MAIL BALLOTS: Processing of vote-by-mail ballots may begin on the tenth business day prior to the election. Processing vote-by-mail ballots includes opening vote-by-mail ballot return envelopes, removing ballots, duplicating any damaged ballots, and preparing ballots to be machine read, but under no circumstances may a vote count be accessed or released until **8:00 p.m.** on the day of the election.

NOTICE OF ELECTION: The Registrar of Voters must publish once in a newspaper of general circulation the notice that ballots will be counted in a central location.

DEADLINE TO MAIL COMBINED VOTER INFORMATION GUIDE AND MAIL BALLOT: Last day to mail combined Voter Information Guide and mail ballots.

(E-0)**

DEADLINE TO RETURN A MAIL BALLOT IN PERSON TO THE REGISTRAR OF VOTERS' OFFICE OR SEAL BEACH CITY HALL: A voter may deliver the mail ballot to the Registrar of Voters' office or the Seal Beach City Hall no later than **Election Day, January 29, 2019 8:00 p.m.**

SEMI-OFFICIAL CANVASS OF ELECTION RETURNS: Beginning at **8:00 p.m.** and continuously until completed, the Registrar of Voters shall conduct the semi-official canvass of votes.

COMMENCE OFFICIAL CANVASS OF ELECTION

RETURNS: The Registrar of Voters will begin the official canvass of the precinct returns. **§ 15301**

**February 28, 2019
(E+30)**

COMPLETE CANVASS OF OFFICIAL RETURNS AND

CERTIFY RESULTS BY THIS DATE: No later than this date, the county elections official must complete the canvass and certify its results. **§ 15372**
